



## **Disclaimer of Liability & General Event Conditions**

### **Disclaimer of Liability**

1. The organizer assumes no liability for damage of any kind to the exhibition stand (stand design, equipment, exhibits), to the property of the booth attendants, for injuries to them or for damage suffered by third parties as a result of the exhibition stand, unless such damage can be proven were caused intentionally or through gross negligence by the organizer or its employees.
2. The liability of the organizer for consequential damage is excluded.
3. The exhibitor releases the organizer from all claims that are made against the organizer due to incidents and damages in the sphere of influence of the exhibitor.
4. The exhibitor is obliged to provide adequate insurance cover himself.
5. The exhibitor is responsible for all personal accidents and damage that arise in connection with the assembly or demonstration of the exhibition equipment.
6. Insofar as the DBG\* has to cancel the event at short notice for reasons for which it is responsible, it is obliged to partially or fully refund the financial benefits received from the exhibitor. The DBG is entitled to withhold part of the amount already received from the exhibitor if the exhibitor's logo was used in the run-up to the event to indicate the exhibitor's support. However, the reimbursement always includes at least 50% of the total amount.
7. With the conclusion of the contract, the contracting party undertakes to comply with the hygiene measures put in place by the organizer before, during and after the event to protect against infection with the Covid-19 virus. Failure to comply with the regulations can result in (partial) exclusion from the event; in this case, there is no (partial) claim to reimbursement of the contractually agreed remuneration. If the DBG is prevented from holding the event due to force majeure, it will be released from the obligation to perform. The cancellation of the event due to official orders to contain the Covid-19 pandemic is also considered force majeure.
8. If the contract is withdrawn, the full invoice amount will be charged if the exhibition space cannot be reassigned.

### **General Event Conditions**

1. The fire protection and other safety regulations according to VStättVO, the existing legal requirements and the recommendations of the VDE - Association for Electrical, Electronic & Information Technologies - must be observed by the organizer. At the request of the fire brigade or the event location, the exhibitor must appoint a fire safety guard. The exhibitor must bear the associated costs.
2. All decorations, fittings, embellishments, etc. must be at least flame retardant (classification B1 according to DIN 4102). Hanging decorations are not permitted.
3. Each exhibitor is responsible for removing any waste and dirt generated during the set-up and dismantling periods and for the duration of the event. Objects brought in (waste, packaging, brochures, information material, etc.) must be taken away again after the end of the event.



4. It is not possible to store stands/equipment in the building after the event.
5. The exhibitor must ensure that the maximum permissible connection values for electricity are not exceeded. Extension cables are to be brought by the exhibitor. The devices used must be tested in accordance with the accident prevention regulation "Electrical systems and equipment" (GUV-V A3) and be in perfect safety-related condition. When supplying power, it must be ensured that no lines are laid across traffic routes and escape routes.
